## ELECTED OFFICIALS -- MONTGOMERY COUNTY

Before the 2009 election there were NO Democrats who were county judges. Twenty-three were from the GOP and no Democrats. In 2009, **Lois Murphy** was elected. In 2011, **Richard Haaz** and **Cheryl Austin** joined the bench. **Gail Weilheimer** and **Steven Tolliver** joined in 2013. In 2015, the group of Democrats became seven, or 1/3 of the bench, with the addition of **Dan Clifford** and **Todd Eisenberg**. In 2017, two more Democratic judges were elected: **Wendy Rothstein** and **Jeff Saltz**. Judges retire at age 75 so change comes slowly, but Democrats are making progress.

2015 was a banner year for Democrats in Montgomery County. All of the row offices are now blue. Democrats are CHAIR and VICE CHAIR of the Commissioners. The only offices held by the GOP are minority commissioner and one jury commissioner -- both positions are reserved for the minority party.

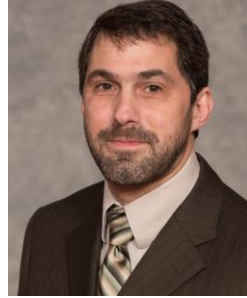
