Poll Workers

Listed names completed petitions and therefore will be on the primary and general election Ballots 2017. “?” indicates a person who has held the position in the past but did not complete petition or indicate whether s/he wished to continue. Open is an unfilled position. Write-in means the person plans to have his/her name written in during the primary.

Judges of Elections can be D or R. Where a member of the GOP has filed, any D in that precinct can get on the ballot as a D candidate by getting 10+ Dems to write in his/her name on the May 16, 2017 primary. Whichever of the D vs R gets > votes in Nov, wins the office.

In addition, there are 2 more paid workers—machine operator and clerk. These 2 officers are appointed by judge or inspector. MO and clerk can be filled by 17 or 18 year old HS student. Voter services trains workers before each election.

Working inside a poll is not political work. You are employees of Montco Voter Services. Pay is \$110 for a day from 6:30am til 8:30pm (with breaks). Judges get additional pay for additional work. Poll workers are trained.
